### DEFINITIONS

The terms defined and used herein shall have the following meanings shown next to them:

- "Application" – the process completed and submitted by the applicant, in order to become a member of the Creative Eateries Privilege Membership.
- "Membership" – Creative Eateries Privilege Membership
- "Transaction" – transaction effected by Member at any Creative Eateries restaurants
- "CE\$" – Creative Eateries dollar issued to members on valid transaction. Each CE\$ earned or issued is equivalent to S\$1.
- "Participating Restaurants" – Creative Eateries restaurants in Singapore which acknowledge and participates in the Creative Eateries Privilege Membership. We reserve the right to make changes to the participating list.
- "We, us, our, Creative Eateries" – Creative Eateries Pte Ltd.
- "You, your, member" – the person who applied for Creative Eateries Privilege Membership and/or whose member's Membership belongs to.

### APPLICATION OF CREATIVE EATERIES PRIVILEGE MEMBERSHIP

- At all Creative Eateries Participating Restaurants in Singapore.
- Membership application fee is at S\$15, payable by cash or credit card only.

### MEMBERSHIP VALIDITY

- Lifetime membership valid in Singapore only.
- The Membership privileges can only be enjoyed by the member.

### EARNING OF CE\$

- Members are entitled to 10% rebates, in the form of CE\$, on the total food and beverage bill when they dine-in or takeaway at any Participating Restaurants.
- 10% rebates on total food and beverage bill do not include purchase of Membership, purchase of Creative Eateries vouchers, miscellaneous charges, service charge, government taxes catering orders, private functions and events more than 15 pax.
- Minimum spending of S\$10 after discount\* (before GST & service charge) is required to be eligible to earn CE\$ on the bill.

### REDEMPTION OF CE\$ AND e-VOUCHERS

- Members must be present at the point of billing to redeem Membership privileges. NRIC or date of birth may be requested for verification purposes.
- CE\$ cannot be used on purchase of Membership, purchase of CE vouchers, catering orders, private functions and events more than 15 pax.
- CE\$ earned or issued are valid for 1 year effective from date of application. No grace period will be given for any unused CE\$.  
(e.g. if application of membership is on 10<sup>th</sup> Feb 2018, CE\$ earned will expire on 9<sup>th</sup> Feb 2019. CE\$ will start accumulating again on 10<sup>th</sup> Feb 2019. CE\$ will expire at the end of 1 year from date of application. Upon expiry, remaining CE\$ in the account will be forfeited.)

## TERMINATION AND CANCELLATION

- Members may, at any time, terminate the membership.
- The Membership may be terminated in the event of any breach of the terms and conditions contained herein.
- Upon termination of the Membership either by the member or by us, member shall not attempt to use the Membership. Such act shall be deemed as fraudulent.

## COMMUNICATION

- Members agree that we shall be entitled to disclose personal particulars to our subsidiaries and CRM vendor, for the purpose of servicing existing members.
- Members agree to allow us to use his/her contact details and personal particulars in order to facilitate Membership privileges and entitlement.

## CONFIDENTIALITY OF MEMBERSHIP INFORMATION

- Members are to keep his/her membership information confidential at all times.

## DISCRETION
